If no, according to a new PA State Law effective 12/31/14, volunteers who have not lived in PA for the past 10 years are required to submit an FBI Fingerprint Record Check prior to volunteering with children. The clearance will cost approximately \$28.75, and volunteers will be responsible for obtaining this clearance. Follow the instructions on what to bring with you to the processing center. Most centers require that you register online first!
